The lodge is a three-story European-style lodge built around a central sunken lobby with an immense rock fireplace, an array of comfortable sofas and chairs flanked by reading lamps, period antiques, and original art. Guests can ski right to the back door of this mountain retreat from the groomed run. Chairlifts are accessible by either walking across the parking area and skiing to chair 6, or taking the hotel van to the lift base. In summer, the lodge is popular as a base camp for exploring Glacier National Park (one-hour drive to the west entrance), Big Mountain, Whitefish, and Flathead Valley.
